THE PROGRAM

In an effort to strengthen the academic cooperation among three universities, we are pleased to announce the NEW program of **Law & Culture 2017** that will take place at the **Faculty of Law, Universität Leipzig, Germany** and **Faculty of Social Sciences, State University of Jakarta, and Faculty of Law, Brawijaya University** with the theme “**Best Practice in Transfer**”

The selected five students from each university will join the lecture series and present the result of working group session during the program of Law & Culture 2017.

THE PARTICIPANTS

- A. Two students will be selected and receive advance payment from the Faculty of Law, Brawijaya University for the undermentioned expenses, and
- B. Three students will be selected and receive reimbursement given by the Leipzig University after their arrival in Leipzig, for the undermentioned expenses:
 - Round-trip airline ticket
 - Accommodation and living allowance in Germany during the Program

Please note that all selected students must pay their own expenses regarding health insurance and passport/visa application fees.

REQUIREMENTS AND ELIGIBILITY

The applicants must meet the following requirements:


- Law students of Undergraduate and Postgraduate programs of the years 2012 until 2016
- Prohibited to graduate and take the comprehensive/final exam until the end of the Program on 11 December 2017 (please complete and sign “Surat Perjanjian” at the back of this flyer)
- Preferably, already have Passport that is valid at least until **29 October 2018**. Otherwise, must agree to apply for a passport at the latest of 7 August 2017
- Minimum GPA of 3.00 (proven by a legalized transcript)
- At least two years old TOEFL score of min. 500, issued by an institution recognized by Brawijaya University
- Pass the selection and interview process
- Submit Surat Perjanjian, the latest academic transcript (legalized) and TOEFL score no later than 28 July 2017, to the Secretary of *Badan Kerjasama Internasional* (see below).
- Submit the copy of passport page containing the holder’s ID and the expiry date (for those who have valid passport) to the Secretary of *Badan Kerjasama Internasional*
